

FALL BETHEL MOTOR COACH TOUR Visiting Warwick, Patterson, Wallkill, and Canada Branch, with Niagara Falls. October 10-18, 2020

Saturday (October 10)

At approximately 6:00am, we will depart from St. Petersburg, FL and travel through the day, with breaks and meal stops (at your own expense), as necessary. Arrive at approximately 5:00pm at the Fairfield Inn by Marriott at Lumberton, NC for our overnight stay. Evening free! Dinner (at your own expense) at nearby restaurants.

Sunday (October 11)

Wake up and enjoy your included breakfast buffet, in time to have your bags loaded on the coach at 8:00am, for an 8:30am departure. Stops and breaks and meals (at your own expense) will be made along the way to the hotel in NY. A meeting will be observed on the video system, if possible, or conducted on the coach. Arriving at approximately 9:00pm for our 3 night stay.

Monday(October 12)

Wake up and enjoy your included breakfast buffet, in time to board the coach at 8:30am, for a 9:00am arrival to Wallkill for our guided tour, to begin at 9:30pm. The guided tour will enable you to see how Bible literature is printed, bound, and shipped to congregations in the United States, the Caribbean, and other parts of the world. A portion of this tour also includes the Bethel Home and an explanation of the production and processing of food for the United States Bethel family. Before or after your guided tour, you may wish to view tour videos and displays in the main lobby highlighting the history of the Watchtower and Awake! magazines, as well as farming and computer operations. You should allow at least 45 minutes to view these displays and videos. A literature counter is also available. After Wallkill, we will depart for a brief visit to a nearby store, that has items that are ideal for Witnesses, such as book covers, meeting and service supplies. Then we will head to America's favorite buffet, Golden Corral, for an included lunch. After lunch, we will return to the hotel. You are free for the evening or you may join the coach, on a shopping trip and dinner run, to the Galleria Crystal Run mall.

Tuesday(October 13)

Wake up and enjoy your included breakfast buffet, in time to board the coach at 8:00am, for a 9:00am arrival to the Watchtower Educational Center at Patterson. The guided tour will describe the work being done at theocratic schools, such as the Watchtower Bible School of Gilead and the School for Branch Committee Members and Their Wives. You will also see displays describing the work done in the offices, which include the Art, Audio/Video Services, and Legal departments. Before or after your guided tour, you may wish to view displays in the main lobby highlighting the history of the worldwide Bible educational work of Jehovah's Witnesses in modern times. You should allow at least 30 minutes to view these displays and videos. A self-serve literature counter is also available. After our tour, we will venture to the Palisades Mall in West Nyak, NY for a lunch stop at one of their 25 dining options.

This is a brief meal stop only. Please no shopping. The coach must depart at 2:00pm, in order to make it to Warwick, our World Headquarters. The guided tour will highlight certain sections of the Office/Services building and the Bethel grounds. Guided tour time: 20 minutes.

Self-Guided Exhibits: These exhibits differ from a standard Bethel tour in that rather than being explained by a designated Bethel tour guide, the exhibits are self-guided. There will be three exhibits:

1. "The Bible and the Divine Name": This exhibit will feature rare Bibles and highlight how God's name has been preserved in the Scriptures despite efforts to remove it. The exhibit will also include a rotational gallery, which will feature additional rare Bibles and Bible-related artifacts.

2. "A People for Jehovah's Name": This exhibit will provide a visual history of the spiritual heritage of Jehovah's Witnesses. Artifacts, graphic displays, and first-person accounts will show how Jehovah has progressively guided, taught, and organized his people to do his will.

3. "World Headquarters—Faith in Action": This is an interactive exhibit that will explain the work of the Governing Body committees and how they help Jehovah's people to follow the Scriptural directives to meet together, to make disciples, to take in spiritual food, and to show love toward one another. We will complete the self-guided sections about 5:00pm, and then return to our hotel. The rest of the evening is free time.

Wednesday (October 14)

Please rise early enough to eat included breakfast at your leisure. We will be loading bags on the coach at 8:30am and departing at 9:00am to head off to Niagara Falls, ON, Canada. Remember: Do NOT pack you proof of citizenship and ID, keep those in your carry-ons. We will make breaks and meal stops (at your own expense), as necessary, while we head to the Canada border, and then on to our hotel, Quality Inn and Suites – Niagara Falls, for 3 nights. Keep in mind, your WEGO pass is 48 hours, so the time you activate tonight, it will expire on Friday night. Or, you can save until later.

Thursday (October 15)

After your included breakfast, we will load the coach at 6:45am to depart no later than 7:00am for our 9:00am tour of the Canada Branch. After our tour we will return to the hotel, with a midway stop at a local mall for lunch, at the food court. Eat lightly, as we will be enjoying an "early bird" buffet at the Skylon tour at 5:00pm, with a view not to be "mist" from your included access to the observation deck. The rest of the evening your are free. Your WEGO gets you access to public transportation through the Niagara area.

Friday (October 16)

Today is a free day, and you are free to explore where ever and however you like. Remember, your included attractions are one time access, you WEGO pass will expire 48 hours from when it was activated. Plan accordingly, have fun, and be safe.

Saturday (October 17)

Wake up and eat your included breakfast and load luggage in time for an 8:00am depature toward home with an overnight stay in Beckley, WV. We will make a brief stop at the duty free shop prior to leaving Canada. Meal stops will be made along the way, along with appropriate breaks. Arrive at the Sleep Inn- Beckley at about 8:00pm.

Sunday (October 18)

After your included breakfast, we will depart at 8:00am to continue our journey home and arrive at approximately 11:00pm.

Any cancellation up to 60 days prior to tour, cancellation fee of \$50 per person applies.

For 59 _ 30 days prior to departure results in \$200 per person fee applies.

Under 30 days there will be no refunds forthcoming.

No refunds available for unused portion of tours. 100% of money will be refunded if trip is canceled by trip organizers, before it commences, due to lack of required number of participants.
